    - Registration of envelope sizes with duplicate sheet media sizes
    - Smith: No real objection
    - Bill: Should be a way to distinguish the orientation/position of the envelope flap
    - Ira: media size names might be the wrong way to go
    - Mike: MSN does differentiate between envelope-only vs. sheet sizes
    - Charles: New sizes are variations on flap position/orientation
    - Mike: Does ISO specify flap location?
    - Uli: Not in my experience when buying envelopes different locations; also dfferences per printer (flap open/closed, etc.), makes sense to have different displayed media names per locale

- Smith: You can have a different displayed name per locale
- Bill: Might need to put address info in a different place based on the flap location/orientation
- Mike: What is the difference between jpn\_youchou3 and existing jpn\_chou3?
  - Charles: I can find out
- Mike: Would like to better understand the definition of the ISO sizes WRT flap location
- Uli: Is there an actual problem you are trying to solve?
  - Charles: Yes, can't print certain sizes (Kaku6 has one rotation, C5 has a different rotation)
- Smith: Can describe this with media-col, would need to encode this in a new keyword for media seem to be unwilling to "let media go" (and use media-col)
- Mike: From the Client perspective, it is doing all the formatting/ orientation work and C5/Kaku6 are the same

  - Smith: Is Management Device defined anywhere else?
    - Mike: Sure there is but can't think of it now
  - Figure 1:
    - Chris: Should arrowheads be double-ended? Or just use the arrow to show the direction of the firmware goes?
    - Mike: If you omit arrowheads then it just shows that one entity talks to another without specifying how
    - Smith: Will add lines connecting management device bits, add a non-IPP client on management device, drop arrowheads
    - Also two "C"'s in the figure
  - Section 4:
    - Line 286: the IPP Printer or System can provide information
    - Use "scenario" instead of "model"
    - Bill: Not talking about autonomous-only, just triggered autonomous
      - Smith: I can add it back
      - Mike: autonomous would allow printer to report status updates to client (update available and will be installed tonight, update was installed, update installation failed, etc.)
  - Section 5.1:
    - Fix section 0 (broken ref)
    - Mike: Change to simply request an update without waiting to return update info, could add a response attribute indicating an estimated time when the Client should expect an update in Get-Printer-Attributes or via notifications, add a keyword to printer-state-

reasons ("firmware-update-check-pending' or something like that) until the check is completed

- Stopped at the end of 5.1
- Smith: Should we limit to SMB or include enterprise? For future discussion.
  - Ira: Send this to the mailing list so we can start thinking about it.
