#### 5 Review of Power Management Model Document

Document reviewed as <ftp://ftp.pwg.org/pub/pwg/wims/wd/wd-wimspower10-20100922-rev.pdf>; comments as follows:

- Cover page: references <ftp://ftp.pwg.org/pub/pwg/wims/wd/wd-wimspower10-20100923.pdf> rather than <ftp://ftp.pwg.org/pub/pwg/wims/wd/wd-wimspower10-20100922.pdf>
- Para 1.4: Question "recommended" in all caps when not a compliance statement.
- Para 3.2.5: Use case that, although understood to be out of scope, is not addressed in requirements or anywhere else. Will this cause question? Normally, Requirements are developed from use cases and Process document indicates that "It is not necessary that the resulting standard meet every stated requirement, but the standard should be explicit about which requirements it does not meet, and why."
- Para 3.3: Suggest rewording so that "should" is in introductory statement and enumerated itemks begin with verb
- Para 5.3 and subparas: indicate that log should not include successive reports for the same component unless there is a power state transition of that component.
- Para 5.7: Correct wording of paragraph
- Para 7.2: Check where power state should be qualified by stable and/or transitional.

- Para 8.1 Item 'I': add "if present" in relation Scanner and Marker compliance requirements

## **6 Other Imaging Power Management Documents**

- Should reflect parallel changes.
- Request that Imaging Power Management MIB be run in various compilers to check for problems.

- Action Items:
